FROM THE PRESIDENT'S DESK

Hello RC22 Retirees, new and experienced!

It's been a busy winter and spring union-wise, never have I felt so grateful for VOTE-COPE and the power of our collective voices. You may have read that Governor Hochul's budget presented two months ago was unexpectedly unfriendly to our public schools as there were cuts in foundation aid across the state, aid that was finally fully restored just last year. It was also a shock to see the proposed elimination of state reimbursement of IRMAA--the annual surcharge in Medicare premiums for higher income earners. If you are in a two income household, you are likely familiar with IRMAA. NYSUT, along with other public employee unions jumped into action, lobbying our legislators to restore foundation aid money, and restore the annual reimbursement of our IRMAA payments. **THERE IS GOOD NEWS!** Our impact was swift and dramatic--foundation aid is fully funded, and so is IRMAA reimbursement in BOTH the NYS Assembly and the NYS Senate's budget proposals, and were in the final budget they passed awaiting the Governor's signature. And even more amazing news, the budget includes a very important first step in fixing Tier Six! Their pensions will now be based on the average of their final THREE years salary instead of the awful final FIVE years.

By now, most of you should have received your reimbursement for your Medicare premiums, and IRMAA which is processed by your school district. Remember that we who receive Medicare reimbursements are a privileged group- most people in our state do not have this benefit. And as you read above, in NYS, the IRMAA component must be approved every year. The Social Security COLA (Cost of Living Adjustment) increases have been so helpful to us in the past 2 years, and they are cumulative over our retirement years. I urge you to fill out a pension deduction card if you haven't already, and make a small monthly direct donation to VOTE-COPE from your pension. You are unlikely to miss a 5-10 dollar reduction every month, and those dollars are used to protect our benefits, and the funding of our public schools. The form is in this newsletter.

GIVE TO VOTE COPE

Your statewide union has a political fund-raising arm called VOTE-COPE. VOTE-COPE is NYSUT's non-partisan action fund that coordinates the voluntary contributions of members and supports NYSUT-endorsed candidates and campaign committees that are pro-public-education and pro-labor. No NYSUT dues dollars are used to support candidates or campaign committees. NYSUT sends rebates to local unions based on a percentage (up to 40 percent) of the contributions VOTE-COPE receives from that local union's members. Those rebates can be used in local activities such as school board races and for passage of school budgets. You can ask your local president how to participate.
